Regarding the information requested by you by letter no. 1294 / 26.02.2019, we communicate you the following:

1. On reference date January 15, 2019, Conpet's shareholding structure is as follows.

The Romanian State through the Ministry of Energy	58.716%
Legal entities	28.552%
Individuals	12.732%.

Conpet SA Ploiesti is the operator of the National Transport System and provides services for the transport of crude oil, condensate and gasoline on equal terms to all producers and suppliers, natural or legal persons, who request it, on a non-discriminatory and transparent basis, based on certain tariffs approved by the Order of the President of the Agency for Mineral Resources.

2. The transport capacity of 20" Bărăganu - Rafo Onești pipeline is 4,500,000 t / year.

3. Between 2000 and 2008, the quantities of crude oil transported to the Rafo Onești refinery were between 700,000 - 1,850,000 t / year, with a peak in 2005.

4. Currently, the pipeline supplying Rafo Onesti refinery with crude oil is not active, the oil dump being disposed of and handed over to the owner (Rafo Onești) in 2013.

5. Provided that the refinery's owner ensures firm guarantees that the crude oil is transported on this route, the transport of the pipeline may be resumed if the following conditions are met:

- the development of a repair works program of 20" Bărăganu - Mărtinești - Onești pipeline, which will last about 1-2 years.
